#### Challenges:

### Overcoming Space Constraints in Denver Facility

Faced with untenable limitations at their old facility on the north side of downtown Denver, Home Depot urgently required a larger space with additional outdoor storage capabilities, as well as improved inbound and outbound access to accommodate heavy loads efficiently. With a growing preference for rail transport amid rising trucking costs and driver shortages, Home Depot aimed to increase inbound shipments by rail. Despite an initial preference to stay close to their existing location and reluctance to consider areas north of E-470, a number of factors prompted Home Depot to expand their location search to North Metro Denver along I-25, including limited availability of large parcels, restrictions on outside storage, and the logistical inefficiencies caused by shared freight lines with commuter trains.

#### **Solution:**

### Logistics, Labor, Location

Recognizing the historic limitations of short line rail opportunities in the market, Broe Real Estate Group, in partnership with its sister company and rail leader OmniTRAX, proposed a bold solution within Access 25 Industrial Park: Create a state-of-the-art, rail-served distribution center for the home improvement giant, complete with the ability to unload rail cars within the building. Strategically located adjacent to I-25 and CR-34, the 386,000-square-foot facility grants Home Depot many competitive advantages, including advancement in efficiency and safety. Featuring cutting-edge design that allows for efficient transloading of heavy items, the facility ensures optimal operations with direct rail access and outdoor storage for both products and rail cars. This streamlined process translates to reduced product damage, faster delivery times, and increased inventory turnover, enhancing overall performance and customer satisfaction. Access 25 provides several tactical benefits to Home Depot, including:

#### Logistics - Dual Served Rail Access:

The facility at Access 25 is the only site within the greater Denver metro area with access to both the BSNF and Union Pacific railroads via Great Western Railroad, the short line rail owned by OmniTrax—a rarity in Colorado. Additionally, Access 25 Industrial Park provides superior visibility and access to both the Denver metro area and Northern Colorado for store and direct-to-customer deliveries.

#### Labor - Available Labor with Strong Work Ethic

The North Metro Denver market has an exceptional labor pool sourced from both Denver and the surrounding Colorado communities; Boulder, Loveland, Fort Collins & Greeley.


#### Location - High Quality of Life

#### Significant Savings

Once Home Depot realized the benefits of aligning itself with a competitive short line railroad, the cost savings became obvious. The company is positioned to save an millions annually through dual rail access and negotiated rates with the Class 1 Railroad.

Both the location and the facility's strong workforce streamlined shipments to retail stores and other distribution centers across the region, and outbound productivity was further enhanced by direct access to I-25, benefiting both retail stores and direct-to-consumer shipments.
